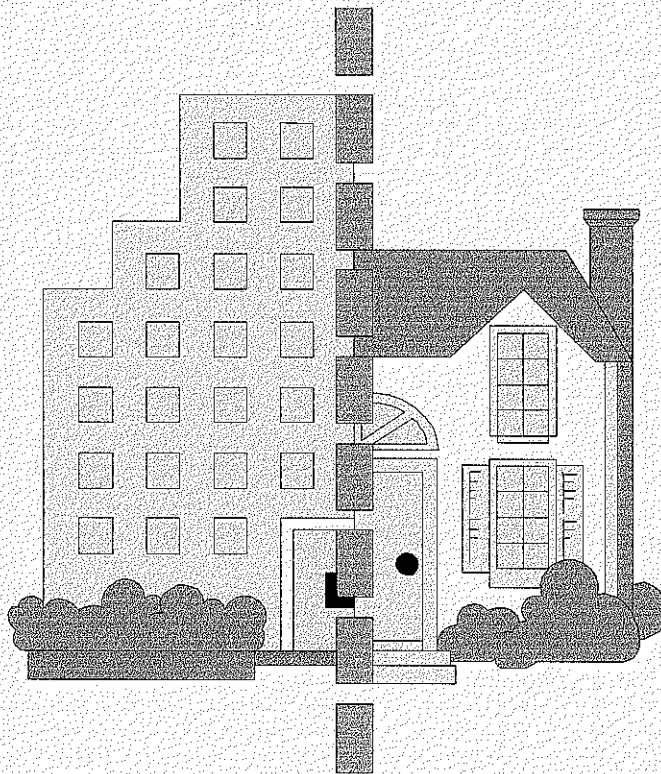




This is to certify that this is the Official Interchange Area Zoning Ordinance of Somerset County, Pennsylvania, Adopted May 13, 1970;




